Description:

Block & Paving Sealer is an effective protection of block pavers and masonry.

Use:

Block & Paving Sealer provides a durable penetrative sealer to a wide variety of materials including concrete, screeds, brickwork, masonry and fibrous sheet materials. The use of Block & Paving Sealer helps provide protection to both new and existing concrete and masonry against water and air borne pollutants.

Advantages:

- 1. Can be applied to green concrete (after 4 6 weeks)
- 2. Non-yellowing
- 3. Dual Sealer and Curing Action
- 4. High Penetration
- 5. Suitable to receive subsequent treatments
- 6. Can be used on horizontal or vertical surfaces
- 7. Vapour permeable allowing the substrate to breath
- 8. Provides increased protection to atmospheric gases including carbon dioxide.

Mixing:

Block & Paving Seal is supplied ready for use.

Method of Application:

By brush, roller or spray.

Directions:

All surfaces must be dry and sound and free from any oil, grease, treatment debris and algae. New concrete must be left for 4 to 6 weeks prior to treatment. Do not apply if rain is likely within 3 to 4 hours of application. Apply to a small test area if in doubt and leave for 24 hours. Apply by brush or roller, work well into the surface taking care not to brush out jointing sand. Apply one or two coats dependent on desired effect. Allow 2 to 3 hours between coats. Product must be left at least 48 hours to fully cure before the treated area can allow any form of traffic. Clean equipment with soapy water.

Dilution:

Shake or stir container before use.

Container Sizes:

1, 2.5, 5 & 25 litres

Coverage Rates:

Coverage will depend on the porosity of the substrate. Guideline coverage is 6m² per litre.

VOC Details:

EU Limit for this product CAT. 2(h): 30g/l (2010). This product contains max. 0g/l VOC's.

Storage:

Store in a cool dry place away from direct heat or naked flame. Containers should be tightly closed.
